Speaker - Kavas H. Thunthy, B.D.S., M.S., M.Ed. Dr. Thunthy is a professor of Oral and Maxillofacial Radiology in the Department of Oral Medicine and Radiology at the Louisiana State University School of Dentistry in New Orleans, since 1975. After specializing in Oral & Maxillofacial Radiology from the University of Alabama in Birmingham, he received his Masters in Education degree from the University of New Orleans. In 1978, he was named a Fellow in the American Academy of Oral and Maxillofacial Radiology and in 1981 was board certified by the American Board of Oral and Maxillofacial Radiology. In the past 33 years of teaching at LSU Dental School, Dr. Thunthy has published more than 70 articles in dental journals and has presented several continuing education courses. He is the author of the textbook entitled Dental Radiographic Diagnosis. Presently, in addition to his teaching responsibilities, he has a part-time practice, specializing in 3D maxillofacial imaging using the ICAT Cone Beam CT. Most of the patients referred to him are from local dentists in need of 3D images of dental ridges before the placement of implants.

Topic of Presentation - "3D Cone Beam Technology and its Applications in Dentistry"

In dentistry, the latest advance in imaging technology is the Cone Beam CT (CBCT). The clinician now has at his/her disposition 3D images of the maxillofacial region. Visualization of all pertinent vital anatomical structures is now possible. CBCT technology also makes it possible to accurately measure and store digital images. The CT scans are used to assist in dental implant placement, third molar extractions and other surgical procedures, TMJ imaging, diagnosis and treatment planning of orthodontic cases, 3-D imaging of skeletal structures, and exact tooth position in relationship to abnormal anatomy. The presentation will include a basic explanation of CBCT, the use of the iCAT Vision software, interpretation of images, and clinical cases of lesions incidentally detected while imaging.

- 2.) Use of the iCATVision software
- 3.) Uses of the CBCT in dentistry
- 4.) Discussion of clinical cases incidentally detected on CBCT images

Statistics Tell Story About Freshmen Dental Class

The Class of 2012 at the LSU School of Dentistry is comprised of 60 students chosen from a field of 250 applicants. There are 37 men and 23 women in the class, with an average age of 24 years. They come from 27 different Louisiana cities and 22 colleges.

The grade point average for the class is 3.6 and the average score on their Dental Admission Test was 19 which translates to the 86th percentile. Fifty-four are from Louisiana, four from Arkansas, one from California and one from Texas.

In their first rite of passage into the dental profession, the students had their white coat ceremony on September 19th in which they made a public oath to the highest ideals of dentistry.

The students were helped into their coats by four members of the faculty who have received awards for excellent in teaching: Dr. Laurie Moeller, associate professor in the Department of Prosthodontics, who is recipient of this year's Copping Award, and the three winners of the Golden Apple Awards, Dr. Kenneth DuBois, clinical assistant professor in the Department of Comprehensive Dentistry; Dr. Tobias Rodriguez, instructor in the Department of Oral & Craniofacial Biology and Dr. Chet Smith, associate professor in the Department of Comprehensive Dentistry.

A Brief History of LSUSD

Dental education has a long history in Louisiana, dating as far back as 1867, with the establishment of the New Orleans Dental College, followed by the School of Dentistry at Tulane University and then the Loyola University School of Dentistry.

When Loyola could not afford to continue its dental program, the Louisiana Legislature authorized the building of a dental school as part of the LSU System. Over the span of four years, operations at Loyola were transferred to the new LSU School of Dentistry. The last class of Loyola dentists graduated in 1971. The first class of 27 LSUSD dentists graduated on June 3, 1972.

Since that first graduation, 4,258 dentists, hygienists and lab technicians have been educated here. Today, this means that 75% of the dental health care workers in Louisiana have been trained at LSUSD. The school is located on a 22-acre track of land, commonly called the City Park campus, that was acquired from the federal government. The 30 frame buildings on the site at that time were used during World War II as housing for the Navy.

In order to construct a permanent physical plant for the school, a grant was obtained from the United States Department of Health, Education and Welfare. The 344,000 square foot project cost \$15,500,000 to build. Of this total, \$10,500,000 came from the federal government and \$5,000,000 came from the State of Louisiana. It was arguably the best bargain the State of Louisiana ever got in a building. Formal dedication of the new school took place on Friday, February 18, 1972.

The flooding that followed Hurricane Katrina caused the school to relocate to Baton Rouge. Specifically, three buildings used for storage on the south campus of LSU were quickly transformed into classrooms, laboratories and offices. Tapping into 40 years of goodwill among the alumni, a network of 182 dentists, surgeons and hygienists in the community agreed to provide the clinical training and experience for our third-year students, fourth year students and residents that were provided in our regular clinics and residency programs before the storm.

A major milestone towards normalcy came in August of 2007 when students, faculty and staff returned to the New Orleans campus. The facilities in Baton Rouge are now being used as a community clinic, which is an addition to the school's satellite dental clinics in Lafayette, Independence and Alexandria.

As of October 1st, Dr. Henry Gremillion is the new dean of LSUSD. His bio can be found in this newsletter. He succeeds Dr. Eric Hovland whose bio can also be found in this program. Prior to Dr. Hovland, our deans were Drs. Jack Rayson, Allen Copping and Edmund Jeansonne. Drs. Rayson and Jeansonne are deceased.

Hollier Appoints Gremillion Dean of LSUHSC School of Dentistry

New Orleans, LA – Dr. Larry Hollier, Chancellor of LSU Health Sciences Center New Orleans, has named Henry A. Gremillion, DDS, Dean of the LSUHSC School of Dentistry. The appointment is effective October 1, 2008.

A native of Shreveport, LSU alumnus and 1977 graduate of LSU Health Sciences Center New Orleans School of Dentistry, Dr. Gremillion will be the sixth dean of his alma mater. He succeeds Dr. Eric Hovland who stepped down after so admirably leading the recovery of the dental school in the aftermath of Katrina throughout its time in Baton Rouge and its return home. Dr. Hovland will continue to serve the Dental School and the Health Sciences Center, taking a six-month sabbatical as an Oral Health Policy Fellow for the American Dental Education Association in preparation to develop a dental public health curriculum and locate dental public health funding opportunities.

Dr. Gremillion was recruited from the University of Florida College of Dentistry where he was the Parker E. Mahan Endowed Professor of Orofacial Pain in the Department of Orthodontics and a member of the Dental Staff of Shands Teaching Hospital. He also served as Director of the Fellowship in Craniomandibular Dysfunction at the UFCD Parker E. Mahan Facial Pain Center, a post he held since 1991. In 2005, he was appointed as Associate Faculty at the Dawson Center for Advanced Dental Education. He has also been a member of the Associate Faculty of the L.D. Pankey Institute for Advanced Dental Education since 1986. Dr. Gremillion serves as a consultant to the Malcolm Randall Veterans Administration Hospital, the United States Army, Navy, and Air Force on Temporomandibular Disorders and Orofacial Pain, and to the American Dental Association's Council on Dental Practice.

Dr. Gremillion began his professional career practicing general dentistry in Cottonport, LA from 1977 - 1989. He was named Cottonport Citizen of the Year in 1989 and he also served on the Cottonport City Council. He was awarded a fellowship at the Parker E. Mahan Facial Pain Center at the University of Florida College of Dentistry in 1989 which he completed in 1991.

Dr. Gremillion has been elected to leadership posts including President and Vice President of the American Equilibration Society and President of the Omicron Chapter of Omicron Kappa Upsilon, the dental honor fraternity.
