HIV RISK: The ADA POLICY

The American Dental Association has adopted the following policy in response to the Centers for Disease Control January 18 Morbidity and Mortality Weekly Report on the possible transmission of HIV from an infected dentist to three patients.

The dental profession has long adhered to a moral commitment of service to the public and an ethical obligation to protect the health of the patient. An advisory opinion to the American Dental Association's Code of Professional Conduct urges dentists who become ill or impaired to limit the activities of practice to those areas that do not endanger either patients or dental staff.

Currently, there is no scientific evidence to indicate that HIV-positive healthcare providers pose an identifiable risk of HIV transmission to their patients. There has been only one documented case of transmission from an HIV-infected healthcare provider to patients during the past ten years of experience with AIDS, an indication that the risk is infinitesimal. The ADA continues to believe that the recom-

mended infection control procedures are effective in preventing transmission of infection.

However, the recent case of possible HIV transmission from dentist to patient has raised some uncertainty about the risk of transmission from healthcare provider to patient. While there is evidence that this dental practice did not consistently adhere to all recommended guidelines for prevention of disease transmission, the precise mechanism of transmission in this case remains unknown. This uncertainty leads to the conclusion that the foremost concern of the dental profession must continue to be protection of the patient. Thus, until the uncertainty about transmission is resolved, the ADA believes that HIV-infected dentists should refrain from performing invasive procedures or should disclose their seropositive status.

The American Dental Association will assist and support infected dentists in sustaining meaningful professional careers.

New budget makes changes in health programs

(From ADA Washington News Bulletin)

The budget law made significant changes in the federal government's largest health programs, Medicaid for the needy and Medicare for elderly and disabled Americans. President Bush signed the legislation November 5, calling it "the most comprehensive and substantial reform of mandatory 'entitlement' programs ever."

■ MEDICAID – The Association took part in a health-business coalition that persuaded Congress to expand the nation's largest publicly funded dental program to cover more poor children.

The law extends Medicaid coverage to all children through age 18 in families with incomes at or below the federal poverty level, a formula that defines need on the basis of family size, income and geographic location.

OBRA also:

★ Requires Medicaid to increase opportunities for pregnant women and children to apply for coverage by establishing sign-up locations at community and migrant health centers and places other than welfare offices;

★ Extends from 4 to 14 days the period during which a **nursing home** must complete the initial assessment of a newly-admitted resident.

■ MEDICARE – Physicians and others including oral surgeons who treat Medicare patients collectively will receive \$27.9 billion less in reimbursements over the next five years than was projected. Medicare beneficiaries will pay \$10.1 billion more toward their care, primarily through an increase in the monthly Part B premium from \$29.90 a month in 1991 to \$46.20 in 1995. \$6.3 billion will be shifted to private insurers.

Except for primary care services, physician fees are frozen until Jan. 1, 1992. Primary care fees increase by 2% Jan. 1, 1991; a 2% increase in all fees takes effect Jan. 1, 1992. Income subject to the **1.45% Medicare payroll tax** increases from \$53,300 now to \$125,000 in 1991.

■ MILITARY – Congress in the Defense budget authorized special pay for reserve medical and dental officers called to shortterm duty in the Middle East as part of Operation Desert Shield.

■ MINORITY HEALTH – PL 101-527 established several new programs for the training of minority dentists and other health professionals and provides statutory authority for an Office of Minority Health, which was created administratively in the Department of Health and Human Services.



NEIGHBORHOOD DENTIST SAVES TARANTULA

Thanks to the kindness of a neighborhood dental clinic in Metairie, Louisiana, Rosie is alive and growing. Rosie is a pet Rose Tarantula.

Tarantulas periodically molt. For a few days after shedding the outer skin, the new exoskeleton is very soft and vulnerable.

Shortly after Rosie's last shedding, her abdomen was damaged. This type of damage can cause loss of hemolymph. If not attended to, a spider will dehydrate and die. The exoskeleton must be patched or stitched. Rosie was patched with dental cement donated by Old Metairie Dental Clinic.

Rosie's wound was first cleaned. Next the dental cement was mixed and applied with a flat toothpick. In a matter of seconds, the cement was set and the spider was saved!

Rosie and her owners send thanks to the doctors and staff at the clinic for the dental cement and instructions in its use. And a very special thanks to them for the time they took to listen and care.

TWO MOUTH RINSES GET ADA APPROVAL

The ADA Council on Dental Therapeutics has accepted two antiseptic mouth rinses for the prevention and reduction of supragingival plaque and gingivitis.

The two, manufactured by Vi-Jon Laboratories, St. Louis, Missouri and the Perrigo Co., Allegan, Michigan, are the third and fourth products accepted in this category.

The other two are Peridex, which is a prescription-only mouth rinse made by the Procter & Gamble Co., and Warner Lambert's Listerine, which is sold over the counter, as are the Vi-Jon and Perrigo rinses.

The Vi-Jon and Perrigo products are chemically equivalent to Listerine. Both manufacturers will market their rinses under dozens of different brand names, depending on their client.

AMERICANS HAPPY WITH DENTAL HEALTH

More than 80 percent of the population consider themselves to be in good or excellent general health and are very satisfied or somewhat satisfied with the present condition of their teeth (or dentures) and gums, according to a recent Gallup survey.

The survey consisted of telephone interviews with 1,000 Americans. Following are some of the survey results.

- Almost all respondents (99 percent) reported using a toothbrush to care for their teeth.
- More than two-thirds of the respondents (69 percent) used dental floss to care for their teeth.
- Females (74 percent) were more likely than males (65 percent) to use dental floss.
 Respondents also reported

brushing their teeth approximately twice a day. On average, respondents thought people should visit the dentist about twice a year. More than one-half reported they had a teeth cleaning done on their last dental visit.

Blue is the toothbrush color most often selected by consumers, according to a story in *The Wall Street Journal*. The story focused on toothpaste manufacturer surveys regarding the likes and dislikes of American consumers.

Some tooth brushing trivia garnered from the surveys:

- 37 percent of respondents say they've been using their current toothbrush for more than six months;
- 47 percent wet their toothbrush before they apply toothpaste;
- 24 percent wet their brush both before and after adding toothpaste;
- 14 percent prefer their toothbrush dry, not adding water at all.

The Journal article stated that "of all businesses, the prize for research may go to toothpaste makers."



NODA PROFILE

NODA's new president is used to leadership

NODA presidents continue to make history. Last year it was the first woman president in the association's 72-year history. This year Dr. Michael Robichaux becomes the first LSU School of Dentistry graduate to ascend to the top post.

Leadership is no stranger to Mike Robichaux. He's held positions of responsibility since his school days. He was president of LSUSD's charter class and founding dean Dr. Ed Jeansonne gives him a great deal of credit for helping to maintain student morale in the school's formative years.

"We occupied the old wooden barracks for most of our schooling," Mike recalls, "but, happily, moved into the new building for our final six months!" Following graduation in 1972, the new Dr. Robichaux was elected first president of the newlyformed Alumni Association.

After two years in the U.S. Navy, Dr. Robichaux in 1974 established his private practice of general dentistry which he continues in his office at 1101 Robert Blvd. in nearby Slidell, Louisiana.

Meanwhile he has continued his active career in helping to advance organized dentistry. He has served NODA via the Board of Governors, treasurer, vice-president, chairman of the long-range planning committee, and delegate to the LDA.

In 1983 he received the Academy of General Dentistry Fellowship Award, currently serves as vice-president of the Louisiana chapter and in 1993 will be president of the Louisiana AGD.

Mike has also been active with the New Orleans Dental Conference, heading up the scientific program committee in 1988. A strong believer in continuing education, he has amassed more than 1,000 hours of post-graduate training.

The 43-year-old president was born in Thibodaux and lived on a sugar plantation for 15 years before moving into the nearby city. In 1969 he married the former Anna Mae Blanchard of Thibodaux. They reside just outside Slidell with their two sons, Myles 18 and Hal 14.

"We live on the Morgan River on seven acres. Our backyard borders on the Honey Island Swamp," says Mike. "My favorite material possession is my John Deere tractor which I use to cut grass, grade my gravel driveway, and move dirt. It provides a wonderful diversion from the delicate, meticulous practice of dentistry."

Another of the president's great loves is golf. He calls it "my most favorite hobby."

"When I grow up I want to be a greenskeeper at a nice golf course," laughs Mike who plays to a three

handicap. He says golf has proven a wonderful family activity. Vacations are often centered on finding and playing new courses.

Mike is active in St. Luke's Catholic Church and has received the Order of St. Louis Medal for his work.

Regarding his plans and goals for NODA, Dr. Robichaux says:

"The New Orleans Dental Association is like a great ship that has been sailing along for over 70 years. I personally am pleased with the direction we're heading and plan no major shifts in its course.

"Balancing the budget, watching expenditures closely, increasing membership, providing a quality program for young graduates, and re-evaluation of the mission and purpose of NODA are some of what I hope to achieve. I want the association to be a little better when my year is up."

West Bank study club completes busy year

A new West Bank study club, Delta Dental Studies, has recently completed its first full year of activities. The club was formed to provide its members with access to continued education and the community with humanitarian services.

The organization requires each of its prospective members to prepare and deliver a continuing education program before becoming a charter member.

Last year's topics included such diverse sub-
