Dr. Moerschbaecher, Dr. Indovina on dental pharmacology

Dental pharmacology is constantly changing, as new drugs are developed. Two areas of immediate concern to all dentists have literally exploded with new knowledge and pharmacologic agents in the last few years.

Dr. Joseph Moerschbaecher and Dr. Anthony Indovina will provide us with an update in these two areas at the next meeting of the New Orleans Dental Association.

The meeting will be held Wednesday, May 15 at the LSU School of Dentistry, Auditorium A, at 7 p.m.

Following a brief business meeting, Dr. Indovina will discuss antimicrobial pharmacology, focusing on the newer antibiotics and their role in the treatment of oral infections. He will also discuss the new AHA recommendations

for SBE coverage.

Then Dr. Moerschbaecher will discuss the pharmacology of conscious sedation, and the newest generation of NSAIDs for non-narcotic management of dental pain.

Drs. Indovina and Moerschbaecher cover the spectrum of pharmacologic expertise. Dr. Moerschbaecher is head, department of pharmacology at LSU Medical Center. He earned his Ph.D. from the American University in Washington, D.C., and has been at LSU since 1983. He is an internationally known researcher in pharmacology. His major research interest is in the area of drug abuse and drug effects on learning and memory. Obviously, he has a strong interest in the non-narcotic management of pain.

Dr. Indovina is an oral and maxillofacial

surgeon in private practice in the New Orleans community. He is an alumnus of LSU, and is highly respected for his ability to evaluate the clinical application and effectiveness of new drugs in dental practice.

This will be the last meeting of the New Orleans Dental Association before the summer break and Dental Conference. Plan now to attend - not only for the informative program, but also for the wine, beer and socializing after the meeting. This is your last chance before summer.

CLINICAL CORNER

Prophylactic antibiotic therapy

The American Heart Association's 1990 guidelines for prophylactic antibiotic therapy are the Association's sixth revision in thirty-five years. The last revision was in 1984. The Council on Dental Therapeutics has reviewed and approved the dentistry sections of the new guidelines.

- Recommended Standard Prophylactic Regimens for Dental, Oral or Upper Respiratory Tract Procedures
- A. For patients able to take Amoxicillin/Penicillin:

Amoxicillin 3.0 grams orally one hour before procedure, then 1.5 grams six hours after initial dose.

B. For patients allergic to Amoxicillin/Penicillin:

Erythromycin ethylsuccinate 800 mg. or erythromycin stearate

1.0 grams orally two hours before procedure; Then one-half the dose six hours after initial dose.

OR

Clindamycin 300 mg. one hour before procedure; Then 150 mg. six hours after initial dose.

- Alternate Prophylactic Regimens for Dental, Oral or Upper Respiratory Tract Procedures
- A. For standard risk patients unable to take oral medications:

Ampicillin 2.0 grams IV or IM 30 minutes before procedure; Then 1.0 gram ampicillin IV or IM (or 1.5 grams amoxicillin orally) six hours after initial dose.

For ampicillin/amoxicillin/penicillin allergic patients unable to take oral medications:

Clindamycin 300 mg. IV thirty minutes before a procedure and 150 mg. IV (or orally) six hours after initial dose.

B. For high-risk patients for whom the practitioner desires to use a parenteral regimen (read reference):

Ampicillin 2.0 grams IV or IM plus gentamicin 1.5 mg/KgIV or IM (not to exceed 80 mg.) one-half hour before procedure, followed by 1.5 grams oral amoxicillin six hours after the initial dose. Alternatively, the parenteral regimen may be repeated eight hours after the initial dose.

For amoxicillin/ampicillin/penicillin aller-

gic patients considered to be at high-risk: Vancomycin 1.0 gram IV administered over one hour, starting one hour before the procedure. No repeat dose is necessary.

Endocarditis Prophylaxis Recommended:*
 Prosthetic cardiac values, including bioprosthetic and homograft valves (high-risk patients)

Previous bacterial endocarditis, even in the absence of heart disease (high-risk patients) Surgically constructed systemic-pulmonary shunts (high-risk patients)

Most congenital cardiac malformations Rheumatic and other acquired valvular dysfunctions, even after valve surgery Hypertrophic cardiomyopathy

Mitral valve prolapse with valvular regurgitation

Endocarditis Prophylaxis Not Recommended:*

Isolated secundum atrial septal defect Surgical repair without residua beyond six months of: Secundum atrial septal defect, ventricular septal defect, or patent ductus arteriosus

Previous coronary artery bypass graft surgery

Mitral valve prolapse without valvular regurgitation (individuals with MVP associated with thickening and/or redundancy of the value leaflets may be at increased risk for BE, particularly men over the age of 45 years)

Physiologic, functional or innocent heart

Previous Kawasaki disease without valvular dysfunction

Previous rheumatic fever without valvular dysfunction

Cardiac pacemakers and implanted defibrillators

■ Dental or Oral Surgical Procedures:*

Endocarditis Prophylaxis Recommended Dental Procedures likely to induce gingival or mucosal bleeding, including dental prophylaxis

Surgical operations involving respiratory mucosa (maxillary sinus)

Incision and drainage of infected tissue Intraligamentary injections

Endocarditis Prophylaxis Not Recommended:

Dental procedures not likely to induce gingival or mucosal bleeding such as simple adjustment of orthodontic appliances or fillings above the gingival margin Injection of local intraoral anesthetic (except intraligamentary injections)

Shedding of primary teeth

New denture insertion

It has been stated (3) "if a dentist has prescribed the 1984 penicillin V regimen for a standard-risk patient previously and it has been effective and well-tolerated, it could continue to be used. For high-risk patients, the oral penicillin V regimen would be inappropriate."

*These charts list selected conditions and procedures but is not meant to be all-inclusive.

The Forum is set for Sunday, October 6, 9-11:30 a.m. Deadline for abstracts is May 15.



FDA TO TEST, SET STANDARDS FOR GLOVES

The Food and Drug Administration (FDA) has approved test methods and minimum quality levels for the billions of rubber and plastic gloves worn by dentists and other health care workers.

The new regulations, effective March 12, standardize manufacturer testing and define the maximum failure rate for the test, according to a news item in the March 1991 *Dental Management*.

The FDA will examine randomly selected samples for tears,



holes and any foreign matter embedded in the gloves.

Gloves will also be subjected to a water leak test, and may not be sold for medical use if leaks are found in more than 25 per 1,000 of surgeons' gloves and 40 per 1,000 of patient examination gloves. The FDA claims these limits can be reproduced in its field laboratories, thus providing a standard level of quality.

Foreign glove manufacturers may be placed on an import detention list if their gloves consistently do not meet the new FDA requirements. Domestic gloves that do not meet requirements will be seized, if necessary, to keep them off the market.

NEW INTEREST IN TORT REFORM

Tort reform is "alive and well" in the U.S., the American Tort Reform Association (ATRA) notes in a report issued recently.

Renewed administration interest in malpractice reform comes as legislatures in at least 28 states consider liability legislation, according to ATRA's 1991 State Tort Reform Outlook

Sixteen states will address medical liability reform, the report reveals. Alternatives to litigation, such as arbitration or administrative processes, are proposed in some states. Others will look at alternative ways of compensating injured persons.

Bills will be considered in 20 states, with reform of the "joint and several" liability rule heading the list. States with recently enacted reforms will face repeal efforts and other challenges in 1991, ATRA reports.

The Boston University Goldman School of Graduate Dentistry is accepting applications for a postdoctoral fellowship in geriatric dentistry.

GROUP CALLS FOR BAN ON SNUFF ADS

A national society of physicians has called for a ban on U.S. advertising of snuff and issued a warning to teenagers about the life-threatening dangers of snuff use.

The American Academy of Otolaryngology-Head and Neck Surgery cites government data showing that, since 1981, use of moist-type snuff has increased 50 percent, while consumption of cigarettes and eight other types of tobacco products has declined.

(Snuff is flavored tobacco that is placed between the cheek and gum.)

"Users of snuff have been found to increase their risk of oral cancer as much as 50 times, and this disease kills 30 to 50 percent of its victims within five years of diagnosis," said Jerome C. Goldstein, MD, executive vice president of the Academy.
