

# Studies link smoking, vision loss

Two articles in the October 9 Journal of the American Medical Association link smoking and vision loss, according to a report in the current American Medical News.

In the first study, the smoking habits of nearly 32,000 female registered nurses between the ages of 50 and 59 in 1980 were followed for 12 years, with information updated every two years.

Researchers found women who were current and past smokers had a significantly greater risk of age-related macular degeneration (AMD) than did women who never smoked, according to AMN. The nurses took part in the Nurses Health Study.

The second study involved more than 21,000 male physicians between the ages of 40-84 in 1982 who did not have a diagnosis of AMD at baseline, the report continued.

Researchers found those who smoked at least a pack of cigarettes a day had an increased risk of developing AMD, as did past smokers, although not as great. The physicians were part of the Physicians Health Study.

# Dr. Kirn: He 'walks the hall'

ext time you attend a NODA dinner or major function, look around. All is in readiness: seating has been arranged, microphone is in place, screen and slide projector are in proper position, sightlines have been checked. Weeks before, the menu has been selected and price negotiated.

Who does all this?

Answer: Dr. Joseph Kirn, NODA's arrangements chairman, who "walks the hall" several times to be certain all of the above are in order. And still has a few tense moments.

"I wonder how many knew that five minutes before Becky Allen was due to go on at the Staff Appreciation dinner, we were at Radio Shack for a microphone extension."

But Dr. Kirn keeps his cool and his cheerful, upbeat temperament, which is one reason the Conference has chosen him year after year to preside over the Committee and VIP Suite as hospitality chairman.

Another reason for Dr. Kirn's good nature these days may be his new offices. After 30 years in the Pere Marquette building, he is now located near the Lakefront at 101 Robert E. Lee Blvd. "where I can see people who told me they were working go by in their sailboats."

Son of a physician and cousin to a number of dentists, Dr. Kirn graduated from Jesuit High and took his undergraduate studies at the University of Southwestern Louisiana. After graduation from Loyola Dental School in 1964, he served for two years as an Air Force flight dentist at Langley AFB, Virginia.

"I rotated through all the dental specialties. It was a phenomenal experience," he recalled.

After discharge he became an associate of the late Dr. Ray Bassich in the Pere Marquette, then ranking probably next to the Maison Blanche Building as a mecca for dentists and physicians. He remained there in his own office until the building was sold recently.

Dr. Kirn, who taught endodontics as LSUSD for five years, has served NODA in a number of posts including vice president and secretary, his current office. He served for a number of years as chairman of the public relations committee. For 10 years he was active in the Conference on

the printed program committee.


Away from the office he can usually be found on his 25-foot Grady White fishing boat, the "Hey Baby," which "I can see from my office." Weekends often have him on his way to South Pass of the Mississippi River and then far out in the Gulf in search of wahoo, tuna and dolphin. It's a three and a half hour cruise, but that's not a strain for his two 200 h.p. motors. Overnight stays are spent at his camp built on a barge at South Pass. If he's not in the office or on the boat, he'll be working out in the gym or walking the aisles of a wine store.

Asked about teachers he remembers, Dr. Kirn names the late Dr. Bob Eastman, "a man of great diligence." A member of the American Association of Endodontics, Dr. Kirn says his special practice interests are endodontics and adult restoration dentistry. He gives credit to his great staff for any of his accomplishments.

Dr. Kirn is the father of two children, daughter Paige, a Georgia Tech graduate who is a mechanical and composite engineer and rocket scientist at Lockheed Martin, and son Brian, a stockbroker with Merrill Lynch, an MBA and a sponsor of some of NODA's monthly meetings.

# Some patients unable to read medical instructions

Many emergency room and clinic patients are unable to read and understand basic written medical instructions, according to an item in the March/April *Pediatric Dentistry*.

Citing *The Journal of the American Medical Association*, the item estimates 40 to 44 million U.S. adults are functionally illiterate and another 50 million are marginally literate, according to the article.

Are these people leaving doctors' offices without understanding what to do to ensure their good health?

A study in 1993 and 1994 at two urban public hospitals found the majority of patients at both sites were poor, had not health insurance and many had not finished high school.

The study found that after examining a standard appointment slip, from 20.8 percent to 31.2 percent of patients could not tell when a follow-up appointment was scheduled.

From 32.5 percent to 59.3 percent of patients were not able to determine if they were eligible for financial assistance based on their income and number of children.

Between 10.8 percent and 30 percent of patients could not read well enough to comprehend preparation instructions for an upper gastrointestinal radiographic procedure.

The authors write that an ethical problem can arise when a patient with limited reading skills has difficulty understanding an informed consent form.



# Plan for more prescription information pushed

Part of a law signed by President Clinton in August could ensure that by the year 2000, 75 percent of patients receive more written safety information with prescription drugs, according to a recent report in *American Medical News*.

The requirement, contained in the appropriation for the Food and Drug Administration for the coming fiscal year, gives groups representing physicians, pharmacists, drug manufacturers and consumers until December 6 to agree on a plan to meet the 75 percent goal which increases to 95 percent by 2006, according to AMN.

If no agreement is reached by the groups, or if the Department of Health and Human Services rejects the plan, the FDA can impose its own plan.

AMN reports the purpose of the requirement is to improve compliance with medication regimens and reduce incidences of adverse reactions. Source: ADA ONLINE, Oct. 22, 1996

# Survey looks at what patients think about dentists

A host of "warm and fuzzy" factors continues to have a profound influence on the quality and comfort of a patient's visit, according to findings of a recent survey done by the Michigan Dental Association.

By and large, patients have selected dentists based on the recommendations of family or friends and, barring any major problems, have tended to stay with their dentist for a long time, notes an article in the November/December 1996 Journal of the Michigan Dental Association.

The dentist/patient relationship of the 90s, due almost universally to the growing influence of restrictive dental managed care, is becoming a less friendly affair, notes the article.

In April 1996 the MDA commissioned an independent study using focus groups to investigate the relative importance of several factors that determine whether and why patients stay with or change dentists.

Based on the results of the MDA survey, what patients want from their dentists are:

- Caring Attitude Patients want to believe their dentists care about them as people.
- 2. Personal Interest and Friendly Demeanor Friendliness and personal interest in the patient and their family by the dentist and staff are strong influences on patient loyalty.
- 3. Respect for Patients A recurring theme among the survey results was the desire to be treated and talked to like intelligent adults, rather than "children."
- Customer Service Ready access to care in emergencies was a powerful loyalty motivator, according to the survey findings.
- 5. Attitudes Toward Children Survey participants noted that establishing a friendly rapport with children, both those who come for treatment and those who may accompany an adult, helps cement the relationship with both the child and the parent.
- 6. Perceived Competence Patients who "like" their dentists also tend to believe the dentists are honest, diligent and good at their work.

The survey noted the primary reasons for changing dentists continued to be largely involuntary. Most participants who had switched dentists within the past two years had done so because they had moved or because their dentist had died or retired.

The primary reasons for contemplating a change in dentists were: location, dental plan requirements; lack of trust; lack of caring and concern; lack of warmth and friendliness; and difficulty in obtaining appointments.

#### CDC: SPREAD OF AIDS SLOWING

The Centers for Disease Control reports that the number of people with AIDS in 1995 was 62,600, an increase of 2 percent from 1994 but less than the 5 percent increase reported between 1993 and 1994, according to the Associated Press.

The growth of AIDS cases among women continued to be greater than among men, and cases among children younger than 13 dropped by 19 percent, according to the report.

Disparities emerged along racial lines, the report noted, with fewer cases continuing to be reported among whites, and more cases continuing to be reported among blacks.

Since 1981, the CDC has received 548,102 reports of AIDS in the U.S.: 462,152 among men, 78,654 among women and 7,296 children. Of those, 343,000 have died. Source: ADA ONLINE 1996.

# DENTAL WORKFORCE FORECAST

The number of both professionally active dentists (all dentists in dental-related occupations, including private practice) and active private practitioners (dentists in private practice) is expected to increase over the remainder of the century and through the first two decades of the next century, according to data in the ADA's Dental Manpower Model 1995-2000.

The growth is expected to be slower than that experienced during the 1980s, representing an increase of only 11.9 percent for professionally active dentists and 11.1 percent for active private practitioners for the 1995-2020 period, according to the Model.

# NODA's Children's Dental Health Month activities underway

National Children's Dental Health Month is underway! NODA has been a local sponsor of this February event for four decades. The annual campaign was begun in Cleveland in 1941 and adopted by the ADA in 1949.

A wide range of educational projects has been launched by the NCDHM committee headed by Dr. A.C. Liles III. These include a seminar for teachers and school nurses, TV and radio spot announcements, and appearances by dentists and others in the media.

NODA members are urged to take part in the "Adopt-a-School" program under which dentists telephone a school near their homes or offices and volunteer to make a talk on lifetime dental care.

Several local businesses have joined in the areawide campaign. Kentwood Spring Water has underwritten the cost of coloring and puzzle sheets on dental care, Schwegmann's has in past years devoted a whole side of their bags, (500,000) last year to the campaign, and Winn-Dixie has used material in its grocery ads.

# Smoking cessation guidelines

The following summary of the Agency for Health Care Policy and Research's guidelines on smoking cessation appeared in the October 14 American Medical News:

- · Ask all patients about their smoking status at every visit.
- · Log all smoking information in patient files.
- Patient encounters as brief as three minutes can be effective.
- · Offer counseling and nicotine replacement therapies as quitting aids.
- · Utilize nurses, physician assistants and other professionals to be more effective.
- Don't assume you will be paid directly for cessation efforts, since they are not covered by Medicaid and Medicare, and private coverage is sporadic.
