#### GOAL 1

I, along with quite a few others here in N.O., have done volunteer work out of the country. I know this service will be a great help to the dentists who go out of their way to help the less fortunate in Third World countries.

We would ask that the doctor, when he returns, write a short article about his experiences along with a photo or two to put in the *NODA News* and the *Times-Picayune*. We can use the good publicity for them as well as the dental profession.

#### GOAL 2

Over the past nine or 10 years, I have been involved with the Legislative Committee mainly because of Ralph Dauterive. With Ralph's retirement, most of the political activity of NODA has fallen into my hands. I am now the

I was surprised to find out recently that less than 10% of our members contribute in any way to political action while the other eight component associations have a minimum of 30%; some give 100%!

This year I would like to have NODA increase our percentage by 25%. I plan to explain in detail in the coming months just what these contributions and participation do for our organization.

We need to impress on new dentists getting out of school just how important they are to us. There is a need to impress on them that we need them in organized dentistry for in numbers there is strength. We must explain that they really have a year to be a member at no cost and then they can decide if they want to stay with us. And it is in that first year that we must show these people how valuable we older dentists can be to them

Being a dentist involves service to our patients, service to our community and most important service to our profession. As we work in our profession we find many ways to do these services.

- We serve our patients by providing the best service possible.
- We serve our community to joining civic, fraternal and religious organizations.
- Some of us seem to neglect the service we owe our profession. I know because it took me over 20 years of being just a dues-paying member to get actively involved by chairing a committee on the state level.

We owe it to dentistry to keep it strong and free from outside interference that tends to weaken it and not to parcel out pieces of our profession to a less qualified group.

We, and in my case in particular, can see the future of dentistry in the younger dentists who are our sons and daughters and other relatives – and believe it or not – we'll probably see some of our grandchildren as dentists. I expect at least two or three out of 11.

I have heard that excitement breeds excitement and I believe it. I am excited about the coming year for me and for you because I intend to get you excited about the future of NODA. I look forward to starting a lot of projects for future presidents to continue.



#### Hepatitis C treatment is approved by FDA

The U.S. Food and Drug Administration has approved the use of Rebetron Combination Therapy to treat patients with chronic hepatitis C.

The treatment consists of Intron A (interferon alfa-2B recombinant for injection) and Rebetol (ribavirin) capsules. The combination had previously been approved only for those patients who relapsed following treatment with interferon alone.

The agency says that when patients receive the two therapies, levels of the hepatitis C virus in their blood appear to be more suppressed than when they receive only interferon. Still, it's unknown how the two treatments work together or whether they will delay the progression of liver disease.

The FDA says that signs of serious side effects – anemia and depression – should be closely monitored by physicians. Both Rebetol and Intron A have been found to cause death or structural malformations in the developing fetus in several animal species.

patients must not become pregnant during, and for six months after, the therapy.

Hepatitis is a blood-borne liver disease. An estimated four million people in the U.S. have chronic hepatitis C infection. In its chronic state, hepatitis C can lead to cirrhosis, liver cancer and liver failure.

## A tradition of dentistry

o say there was a tradition of dentistry in the family of Dr. Harold F. Smith, Jr. is putting it mildly. Dr. Smith's father and three of his father's brothers were dentists!

With all those dentists around him, it was only natural when he was in high school for Harry Smith to say to himself, "I think I'll give it a try." He adds: "I'm glad I did."

Today Dr. Smith has a well-established practice at 4440 Chastant St. in Metairie in office facilities he shares with Dr. Richard Gallagher.

After Jesuit High came Loyola University, alma mater of his father and uncles, for pre-dent, followed by four years of dental school leading to his DDS in 1967.

A two-year stint in the Navy saw Dr. Smith serving as a dentist in a U.S. Marine Air Wing at Cherry Point, North Carolina.

They are the proud parents of two children, a son, Geoffrey, 24, a graduate student in the MBA program at Loyola, and a daughter, Sarah, 20, an undergraduate at Louisiana State where she is majoring in vocal performance.
