

The ADA came out with this and tried as hard as they could to sell it to the organization as a whole. As most of us know, it did not pass at the San Francisco ADA meeting. Yet, the ADA HAD INVESTED QUITE A BIT OF TIME AND MONEY IN THIS AND DID NOT WANT TO SHELVE IT.

They asked for at least five states to take on a public awareness campaign to which they would contribute. The LDA was one of those states to put this issue before its House of Delegates in March, and it did pass.

As a result, we will be assessed \$150 beginning with our Year 2000 dues for the first year for this public awareness campaign; renewable each year for three years. It is possible that we may have this assessment for only one year if the LDA house does not vote to renew it in March 2000.

According to my observation, there was more than enough information out there for the average member to be aware of this issue. The NODA delegation was about evenly split on the issue and voted that way to LDA House of Delegates in March 1999. It was the rest of the state that voted overwhelmingly for this campaign.















The average number of dental implants surgically placed by dentists who perform the procedure nearly tripled from 1986 to 1996, a new ADA survey shows. In 1986, the average number of procedures per implant-placing dentist was 17.7. By 1996, this average had climbed to 51.5.



The number of implants placed by oral and maxillofacial surgeons who perform the procedure rose from an average of 34.3 implants in 1992 to 62.4 in 1996. General practitioners who perform the procedure placed an average of 17.2 surgical dental implants in 1992 and an average of 21.0 in 1996.



Those simple forms, compliments of NODC, INC., will relieve the local AGD of the costs and burden of providing an on-site representative. Use of this form will eliminate long waiting lines to obtain on-site AGD credit and will eliminate the tracking of multiple voucher slips.

NODA PROFILE

A many-faceted career

Dr. Kathryn Sturm's career in dentistry has been one of unusual and interesting facets.

Born and raised in suburban River Ridge, she has practiced dentistry throughout her entire career on Magazine St. in the uptown section of New Orleans. Dr. Sturm is a graduate of Archbishop Chapelle High School and Loyola University.

After completing her dental hygiene degree in 1972, she practiced for four years. During this time, Dr. Sturm began taking night classes to become a dentist, and in 1980 she graduated from LSUSD. After graduation, she returned to the office of Dr. Ronald Leggio as an associate dentist.

After nine years of practicing with Dr. Leggio, she and her husband, Marlin Sturm, completed the construction of their office building. Resembling a French chalet, the office occupies the rear of a large European-style courtyard, a parking area by day but secured behind a large wrought-iron gate by night.

At one time, the property on which the building stands was a nursery. The decision was made to tear down the termite-ridden building, and the Sturms contacted architect Ron Domin.

"I had long admired the job Ron did in converting a gas station at Jeff Davis and Banks St. for his own office," she recalls. "I asked him to do something like that for me." The result was the classy structure on Magazine Street. It looks diminutive from the street but is large enough to house 10 operatories and spacious business and employee areas.

The personable dentist looks fondly on her career. She now practices with Dr. Stephanie Phillips and Dr. Kim Tolar; two full-time hygienists, and five chairside assistants. Her husband, Marlin, remains on staff as the building manager along with a full-time business manager and office assistant.

She has pleasant memories of her student days at LSUSD, especially her classes with Dr. Lou Grush in dental morphology and Dr. Shawkey Muhamed in occlusion and TMJ. Dr. Sturm returned to LSUSD two years ago to work with senior dental students as an adjunct faculty member. She has also welcomed dental students into her office as part of the mentoring program.

In the early days of the AIDS crisis in New Orleans, Dr. Sturm received a life-changing

call from the NOAids Task Force. After agreeing to see one patient who was seriously ill, she soon became known as the "AIDS" dentist as many patients learned of her knowledge and compassion.

She saw that this group of patients was in dire need of dental care to assist them in warding off the opportunistic infections they were facing. Thus, Dr. Sturm became an early pioneer in the dental treatment of AIDS patients but says, "the acceptance and treatment of AIDS patients is not so unusual anymore."

A delegate to the LDA, Dr. Sturm worked for 10 years on the New Orleans Dental Conference. "I hope to return when the children are a little older," she adds.

The Sturms have a home on State St., "only five blocks from the office," she adds. The family travels yearly to Colorado for skiing and recently returned from a summer vacation in Cancun. Their children, Zachary Logan, 14, and Olivia Kathryn, 11, attend nearby Isidore Newman School.

Summing up, Dr. Sturm remarks: "I have made the right choice in dentistry. I love the office. I have a great staff." Sounds like one happy dentist.

ALLIANCE NEWS

Dr. Gaubert wins Fund drawing

Dr. Jimmie Gaubert, general dentist in Terrytown, held the lucky ticket for the 1999 ALDA Fund Development Campaign. Dr. Gaubert chose to receive the cash amount of \$2,000 as his prize in lieu of the five-night trip for two to San Francisco/Napa/Carmel.

The Fund Development Drive is sponsored annually by the Alliance of the Louisiana Dental Association (ALDA), a non-profit organization of spouses of dentists who are practicing in the state of Louisiana. This year seven districts – Acadiana, Bayou, Greater Baton Rouge, Northeast, Northwest, New Orleans, and Southwest – participated in the drive.

Sixty percent of the proceeds from each district's drive is returned to the participating districts to fund dental health education projects at the local level. This year's drive raised \$12,000, of which \$7,200 will be used to promote dental health education in the districts in which the money was collected.

Dentists in the New Orleans District sold 63.5 books of tickets valued at \$2,540 of which \$1,524.00 was returned to the district and earmarked for the promotion of dental health education. The 69 participating dentists and Gwen Giacona, district chairperson, are to be complimented for their efforts.

For the first time in the 10-year history of the fund development drawing, all of the tickets were sold thanks to the support of the dentists across the state and the effort of the district chairpersons. Serving as district chairpersons for 1999 were Linda Alesi (Acadiana), who also organized the state-wide drive; Donnell Zeringue (Bayou), Pam Ragusa (Greater Baton Rouge), Lynna Caples (Northeast), Carol Zaffater (Northwest), Gwen Giacona (New Orleans), and Amy Churchman (Southwest).

The Board of the Alliance of the Louisiana Dental Association, which sponsors the Fund Development Drive, voted at its March meeting to donate \$1,000 to LADPAC from the proceeds of this year's drive. The remainder of the state funds is earmarked for a statewide campaign targeted at Baby Bottle Mouth.

In fact, it is necessary for them to notify the board, in addition to the society or association, that they are indeed retiring from the practice of dentistry.


