## The dentist & confidentiality

Although dentists' confidentiality requirements are clear when dealing with adult patients, their legal and ethical obligations can be conflicting and confusing when dealing with adolescent patients.

According to an article in the *Illinois Dental* News, June 1997, dentists can face sticky legal and ethical issues. Minors often argue that they are able and entitled to make their own confidential treatment decisions.

Parents, however, say they have the right to be informed about their children's treatments because they are legally responsible for them, have to pay for the care and have better judgment.

Some health care providers argue that not maintaining adolescents' confidentiality will make minors hide important information, especially about drug use, sexual activity, pregnancy and venereal disease. Withholding this information could adversely affect the patients' care.

Dentists who find themselves in a situation with minors who want health care information kept from their parents should consult an attorney to determine the best course of action. Document the circumstances and the reasons for the actions. Keep in mind what is best for the patient, but ask your attorney to make sure you follow the law while doing so.

#### Budget to benefit dentists

(From the ADA's Dental Advocate)

Grassroots dentists responded to numerous targeted action alerts during the weeks of negotiation leading up to passage of the massive tax and spending bills that make up the balanced budget agreement that President Clinton signed in early August.

The budget deal contained some good news for dentistry, both in near-term rewards and long-term progress. Here's a summary of the more significant elements.

#### **Tax Provisions**

Several provisions will benefit dentists as individual taxpayers. These include reductions in capital gains rates, an increase in the deductibility of health insurance for the self-insured from 40 percent to 100 percent by 2007, and a deduction of up to \$500,000 in profits from the sale of a home.

Most notable for new dentists is the inclusion of a \$2,500-per-year student loan interest deduction (phased in from a \$1,000-per-year starting point), for which the ADA – and especially the Grassroots Action Teams – deserves much of the credit.

#### **Patient Protection**

The budget process also offered the ADA and its allies in Congress the opportunity to test support for several PARCA-style patient protection measures in Medicare and Medicaid, many of which made Congress's final cut.

They include versions of a gag-clause ban, a prohibition of discrimination by degree of provider, and a "prudent layperson" standard for coverage of emergency room visits.

The long list of patient protection measures in the two programs reads remarkably like the Norwood bill and is an encouraging sign of Congress's increasing awareness of the need for such law.

#### Coverage for Uninsured Children

Among the more significant health-related elements of the budget was the so-called "kidcare" provision that seeks to provide health coverage to millions of uninsured children. The

Certainly, Congress signaled its intention in the final bill language, which encourages the states, "in making dental coverage and service provision decisions, to recognize the importance of oral health for children and the role that regular preventive and restorative dental care plays in addressing pediatric dental and oral diseases."

#### Dues notices to come early

Thanks to NODA's updated computer software program, the Central Office expects to bill 1998 dues renewal forms by November 15 rather than in December.

This will give our members more time to pay their dues prior to the January 1 deadline. If you do not receive your form by November 20, call the Central Office and another form will be sent to you.

When you receive your form, please pay particular attention to the "Mandatory Disclosures" on the reverse side of the form and take a copy of both front and back for your records and future tax preparation.

The Federal Government has notified us that they will be imposing stringent control and reporting requirements beginning in 1998 with regard to all "P.A.C." contributions. For example: 1) You are prohibited from including your P.A.C. contribution in your dues payment. Federal law requires a separate, personal check be issued made payable to "P.A.C." 2) By federal law, NODA and the LDA will now be required to report and transfer all P.A.C. contributions within ten days of receipt.

### Americans are satisfied with their dental care

The December 1996 issue of *Consumer Reports* contains the results of the magazine's survey of 52,000 subscribers which found that the readers overall were very pleased with their dental care.

Eight in ten respondents reported that their dental care is very good to excellent, and 96 percent told *Consumer Reports* they had confidence in their dentist's technical competence.

Three-fourths of the readers surveyed visit their dentist at least twice a year, but the article states there is room for improvement in home oral health care.

The survey found that nearly one-third of the respondents brush their teeth only once a day and less than half floss daily.

The American Dental Association recommends brushing at least twice a day with a flu-



Meanwhile, he is busy planning the family's next camping trip. The Brannens are tent campers and "this is a great time of the year for it," he says.


The Brannen family includes his wife Ruth and children Sara, Justin, Katie and Kristyn, and grandson Tyler.

#### Study: Dental X-rays can detect stroke vulnerability

Citing a University of Buffalo study, the Washington Post recently reported that panoramic radiographs "can sometimes turn up a key sign of vulnerability to stroke."

Dental X-rays also pick up calcium deposits in the carotid arteries in the neck. Calcification of these arteries, which supply blood to the brain, "is a sign of advanced atherosclerosis, a major cause of stroke," the *Post* reported.

"Researchers said dentists should look for evidence of calcium deposits in the carotid arteries shown on X-rays and should refer patients with such evidence to a physician," the *Post* noted. Of the 2,752 new patients screened at the University of Buffalo dental clinics over two years, about 5 percent were referred to a physician because researchers found evidence of calcification in the carotid arteries.



So far, as a "grown-up," I have been single and married. I have taken risks and taken the safe route. I have valued status, power and recognition. I have devalued status, power and recognition. These phases and stages have been part of my "grown-up" time. However, I also have a need and desire to recapture the simple joys of childhood and retain the appreciation of a sunset and the trees outside my door.

Does that mean I am retro-"grown-up," or a regressive "grown-up?" Being "mature" and "grown-up" often means staying in a destructive work environment for the benefits of material gains rather than using talents fully and doing something for which we have a passion.

A friend of mine just retired after 40 years at the same job. He is proud of his stable and predictable life. Doing the same thing for 40 years scares the hell out of me, though. Who is the "grown-up?"

I want to continue to stretch, to meet new challenge, to learn, to create and never to have all the answers. I want to remain open, to evaluate and reorganize myself and my priorities as I work to develop myself.

I won't "grow up" (if I'm lucky). I like to think there will always be new challenges, regardless of my age. I intend always to hold my options open – to perhaps join the Peace Corps at 50, or study philosophy at 60, or move to Alaska at 70 – but never to stop growing and stagnate.

I wish someone would ask what I want to be when I grow up. I would take a day and tell them.
