## News from the Central Office

Dues News... All members should receive their 2002 dues renewal forms mailed the last week in November, BY DECEMBER 15TH. If you do not receive your form by that date, call either Mona or Alice at the Central Office, 834-6449, and another form will be sent immediately. Remember dues for the year, 2002 are due by January 1, and must be paid by March 31 to maintain membership in good standing.

## President's Message

hat a year this has been! Believe me, I never anticipated the challenge to the nominating committee's slate and the initial resolutions presented to change the bylaws of NODA early last year...

These were problems to handle before the horses were even out of the gate. With so many important issues facing dentistry today, I can assure you that I was unprepared for and distressed with the discord within our own organization.

There was no way to tackle pressing, broader issues until the deep-seated and long standing problems within our own organization were solved. The positive here is that the democratic process inherent in the parliamentary procedure allowed full discussion and grievances were fully aired. For the first time in years members came out in droves to listen to the discussion, voice their views, and vote.

ith 75-80 percent of you voting for the nominated slate and against the resolutions put forth to dismantle the slate, I proceeded with the support of the majority of NODA members. At the same time, however, I was sensitive to and enlightened by the 20-25 percent of members with the opposing view.

My vision and goals for NODA were clearly stated in the NODA installation speech in March and in the March 2001 issue of NODA News. Let us look back at the initial goals and see where we are now.

In continuing the vision begun by Dr. Jim Roethele, the website is up and running with

Many of you have missed the post-it stickers. The printing of the stickers was delayed because the complete schedule of speakers for the year was only recently finalized. The stickers will return next year.

second goal was to work toward redefining the roles of the New Orleans Dental Association, The New Orleans Dental Conference, and the New Orleans Dental Enterprises.

NODA members worked together several years back to create the good relationship between NODA and NODC. It is important to view the Conference Committee as an inherent part of NODA itself. More and more young talent and new faces are coming into NODA through the Conference and more of this talent is volunteering to work in both areas: building strong leaders in both areas.

This is a good thing. The Conference is a committee of NODA that is very successful and profits from the Conference are turned over to NODA. These profits are non-dues revenues that contribute to a very important part of our operating budget.

The NODE (New Orleans Dental Enterprises) president, Dr. David Hildebrandt, is working hard to seek other endorsements for non-dues revenue from reputable businesses. I think the long-term success and continuity of NODE, however, is dependent on a core committee structure similar to the New Orleans Dental Conference Core Committee. Although the core committee-type structure is not in place yet, I hope that Dr. Gia-

cona is able to proceed with this vision for NODE in his upcoming Presidency.

nother goal I had was to pass a by-laws change that would allow NODA to have full process with elections before the LDA nominating committee meets each January. With our elective process completed before the LDA nominating committee meets each January, any debate within NODA regarding submission of nominees to the LDA is resolved beforehand with December elections.

In addition, the incoming President will lead the caucus of delegates at the LDA House of Delegates in March. In the past the President-Elect led the caucus, as our installation of officers were not held until after the LDA House of Delegates meeting. Although the President is technically supposed to lead the caucus according to LDA by-laws, our previous by-laws did not install the officers until the Installation Dinner that was often held after the February elections and after the LDA House of Delegates meeting in March. This was a technicality that perhaps doesn't matter most of the time, but if there is controversy it is important. Our by-laws



# NODA member authors history of LSU Dental School

The title of the book is, "From the Wolfpack to the Tiger Den: the First 25 Years of the Louisiana State University School of Dentistry."

The author is Dr. Frank L. Herbert, a graduate of the Loyola Dental School '48, long-time practitioner, and now professor emeritus at the LSU Dental School.

It was first unveiled at LSU Alumni Day in 2000 when 90 copies were sold. Sales now exceed 1,500. Copies are available at the LSU Book Store.

The book was five-year project, Dr. Herbert recalled, "three years in research and two years to write." He said that he had for some time thought that there should be a history of LSUSD, especially as it approached its 25th anniversary.

Once as he discussed it with Dr. Allen Copping, a dentist who was also president of the entire LSU System, Dr. Copping remarked: "Why don't you do it? You're a writer." Dr. Herbert took on the task.

Although meticulously researched and carefully documented, Dr. Herbert's recounting of the dental school's story is anything but dull reading. As he relates, Dr. E.W. "Danny" D'Anton, author of the 50-year history of the University of Texas Dental Branch at Houston, "aimed me in the right direction from the beginning. He advised me to include lots of anecdotes to give the book a vital spark, a personality of its own."

This technique, plus Dr. Herbert's own knowledge of Loyola where he gained his DDS degree, and his friendship with so many of the intimate players, make his recounting of the complicated but brilliantly rendered transition from a 57-year-old privately operated dental school to a much larger state-operated institution fascinating reading.

But this is only one of the developments of LSUSD that Dr. Herbert skillfully covers. A former faculty member himself, he related in detail the development of the faculty and the highest priority the founders of the school and subsequent deans and department chairmen have placed on the instructional staff.

As Dr. Herbert states at the end of his 394page chronicle of the LSUSD success story; "This has been a story of the people and events that shaped the development of the LSU School of Dentistry into a world leader in dental education during the first twenty-five years of its existence."

Dr. Herbert is a former president of NODA and LDA.

## Nat'l Children's Health Month plans moving to completion

NODA's plans for sponsoring the 2002 areawide observance of National Children's Dental Health Month February 1-28 are moving ahead briskly.

First of many activities planned will actually take place in 2001. It's the annual Seminar for Teachers and School Nurses to be held in January at the LSU Dental School. Dr. Louis Lacour and Dr. Jason Parker are heading up the campaign that covers New Orleans and surrounding parishes.

## Ten practice tips for the new dentist

Dental school is not where future dentists learn the finer points of running a business, according to Dr. Barbara Mousel in an article in the September Illinois Dental News.

"In four years, there isn't time to focus on much outside the clinical aspects of dentistry,"

Mousel offers new dentists some recommendations for facing the tough issues and decision of starting a practice.

- 1. Stay current on student loan payments.
- 2. Buy insurance coverage,
- 3. Choose a lender who understands service businesses.
  - 4. Borrow enough for working capital.
- 5. Be cautious about signing on with PPOs
- 6. Carefully select equipment and delivery systems.
  - 7. Get your name out there.
  - 8. Smile and talk to your patients.
  - 9. Use the services of quality consultants.
  - Join dental organizations.

In dental school, Mousel says, opportunities are slim for learning how to manage schedules, people or finances, let alone considering such things as office design and overhead control.

# Dr. Parker, staff care for Jamaican children

Dr. Jason D. Parker is another NODA dentist who donates his time and skill to performing much-needed dentistry to groups in foreign areas.

Dr. Parker, along with his assistants, Lillian Lopez and Jeanne Valladarez, spent a week in Ocho Rios, Jamaica, British West Indies, where they provided comprehensive dental care to more than 600 children of St. Ann's Bay.

The project is a joint venture of the Rotary Club of Gretna of which he is a member and the Rotary Club of Ocho Rios. While in Jamaica, the trio worked 10 or 12 hours a day for seven days, but still found time to enjoy the region and made many friends among the welcoming people.

They used a self-contained mobile dental unit contributed by Rotary International, performing approximately 700 procedures that would have cost approximately \$60,000, Dr. Parker said. The VFW provided supplies for the dental trailer.

He added that Colgate is donating another mobile unit so that more and faster services can be rendered.

The Gretna dentist will return next August or early September. He invited other practitioners to join the program next year. "There are just not enough hands to accomplish all that needs to be done for these children," he said.


