Drs. Ganucheau, Kent honored by LDA

Metairie dentist Dr. Edmond J. Ganucheau, Jr., and Dr. John N. Kent, chief of oral and maxillofacial surgery at the LSU Medical Center in New Orleans received the Distinguished Service Award from the Louisiana Dental Association during its 122nd Annual Session on March 16, at the Sheraton Baton Rouge Convention Center Hotel.

The Award is the highest honor bestowed by the LDA. It is presented to individual members who have exemplified the highest standards of professional conduct in dentistry and have made extraordinary contributions in organized dentistry and their community.

Dr. Ganucheau earned his DDS in 1960 at Loyola University School of Dentistry, where he was recognized as the outstanding senior by Delta Sigma Delta. He is a Fellow of the International College of Dentists, the Academy of General Dentistry, and the Pierre Fauchard Academy.

A member of LDA and ADA for 41 years, Dr. Ganucheau served two terms as president of the New Orleans Dental Association. He has chaired the New Orleans Dental Conference and represented the NODA on the LDA board of directors. In the year 2000 he received NODA's Honor Dentist Award.

In addition to participating in the Donated Dental Services program, Dr. Ganucheau volunteers for civic organizations and his church. He is a supporter of the Boy Scouts of America, having previously earned the distinction of Eagle Scout

Dr. Ganucheau maintains a general dental practice in Metairie with his son, Byron.

Full-time education and research has occupied the career of Dr. John N. Kent since he received his DDS in 1963 at Nebraska. After three years in the U.S. Public Health Service, Dr. Kent received his oral and maxillofacial surgery residency training at the University of Texas, in Houston.

He has served as a faculty member at the University of Texas in Houston, University of Iowa, and has been the department head of oral and maxillofacial surgery at LSU and chief of oral and maxillofacial surgery at Charity Hospital in New Orleans since 1973.

Dr. Chaney, a member of the New Orleans Dental Association, has been in private practice of general dentistry in New Orleans since 1989.



If a member has something to do, he or she will feel they are part of an organization that is worth the dues. If they see they can make a difference, they are more likely to stay in a professional organization. In today's world where a dentist can get insurance, dental supplies, office supplies, mortgages, phone discounts, credit cards, waste disposal, continuing education, and so on . . . at discount prices without being part of ADA, LDA, and NODA . . . we have to look at other ideas to keep and

increase our membership.

We have to convince them that being part of organized dentistry is belonging to the tripartite of ADA/LDA/NODA that will represent dentistry at the national level . . . that will lobby for them at the local and national level . . . that will do more than just provide continuing education.

They need to be informed that the ADA has successfully lobbied against further intrusive OSHA standards such as the proposed Ergonomic Standards; the ADA led the fight against the IRS forcing a rule change that will continue to allow practices grossing under 10 million a year to stay with the more simplified cash accounting rules rather than be forced to the more complex and time consuming accrual accounting rules.

Our members and future members need to know that the ADA is fighting for us against insurance company intrusion of the patient-doctor relationship.

They took on Aetna, and now they just announced they filed suit in California against Wellspring and a subsidiary of Blue Cross of California claiming interference with the patient-doctor relationship.

The ADA got OralScan Labs to sponsor advertising campaigns promoting oral cancer recognition at the dentist's office. And all it cost us, that is the ADA, is staff time. Dentists need to know the value of their dues and that we, their leaders will continue our vigilance in insuring that their dues are well spent.

Range/Strategic Planning Committee discussed ways to enhance the Mentoring and Membership Committees. Programs involving the dental school and their students were discussed. I would like to see more of our experienced members really get involved.

We need programs that will inform these future dentists of what they have to face . . . not scare them . . . but help them in their transition into private practice in general dentistry or one of the specialties. NODA invited some senior

He was appointed Boyd Professor at LSU in 1983 and has served as president-elect of the medical staff at University Hospital and president of the Louisiana Society and the Southeastern Society of Oral and Maxillofacial Surgeons.

In 1988 the LSU department received the LSU Medical Center's first one million dollar chair, the James R. Peltier Endowed Chair with Dr. Kent as its first eminent scholar. Dr. Kent's teaching and research includes authorship in 15 textbooks and over 250 journal and abstract publications.

Marquer Award to Mr. Lloyd Brandt

The Dr. Victor Marquer Award is presented to a non-dentist who has rendered unusual and meritorious service to the New Orleans Dental Association. It would be difficult to find a recipient more worthy than this year's honoree – Lloyd Brandt, Sr. of New Orleans.

Lloyd Brand, Sr. was born on February 19, 1903 and grew up in the New Orleans French Quarter. On February 19 of this year, Mr. Brandt celebrated his 99th birthday. Mr. Brandt was one of 11 children, six girls and five boys. His father was a shoemaker.

At 16 years old, Mr. brand was hired by William Franz, a manufacturing jeweler. After working for several years for various jewelers, including Adler's, Mr. Brandt purchased the business of his bankrupt employer, and started his own jewelry business, Brandt Brothers.

Nearly 65 years ago, on the recommendation of a friend, Mr. Brandt scheduled a dental appointment with Dr. J. Melville Smith. Because Dr. Smith and Mr. Brandt loved to hunt & fish, they became close personal friends. On one of Mr. Brandt's dental appointments, he complained to Dr. Smith that after being finned by a catfish, his right thumb was bothering him.

During the appointment, Dr. Smith took an X-ray of Mr. Brandt's thumb which indicated a piece of catfish fin had remained in the thumb. Mr. Brandt brought the X-ray to his physician and had the catfish fin removed.

When Dr. Smith became active in the New Orleans Dental Association, he asked Mr. Brandt to make a key for the past president of the dental association. Mr. Brand agreed and has been making the past president's key for all those years.



VETERAN PROFESSOR IS DEAD

Remembering Dr. Vic Halperin

Dr. Victor Halperin, eminent pathologist, teacher and researcher who guided the Loyola University School of Dentistry through its final years of existence as its dean, died at his home in Coconut Creek, Florida on February 7, 2002, after a year-long regimen on dialysis battling kidney disease. He was 86.

Dr. Halperin had made his home there since his retirement from LSUSD as assistant dean for research and development in 1980.

Halperin was a native of New York and a transplanted Southerner by way of migration to the University of Mississippi where he received his predental education. In 1941 he received his DDS from the University of Illinois Dental School

He returned to New York to enter

private practice, but soon entered the U.S. Army Air Corps in which he served as a dentist in North Africa and Italy, collecting three battle stars along the way.

In an effort to soften some of the most brutal battle experiences of WW-II, he jested that some of his best amalgams were shot down over the Kasserine Pass.

After two postwar years of private practice, he joined the general dentistry staff of a Veterans Administration hospital where he met the noted oral pathologist Dr. Hamilton B.G. Robinson who became his mentor.

This precipitated his interest in Oral Pathology, and he became certified in that specialty in 1952. Fortunately for us, he recognized his preference for academics and became affiliated with the dental school at Emory University in 1955. The rest is history, if not legend.

Known for his ready wit and jocular personality, his students loved him. Many still fondly recall anecdotes that bring to mind lessons learned in his classes.

He held many high offices and received many honors but most notably Vic Halperin's greatest recognition was the reverence with which he was held by all as a teacher, administrator, and friend.

He is survived by his wife Ann, a son Henry Halperin, MD, a daughter, Mrs. Randi Olson, five grandchildren, two great grandchildren, and a host of admiring colleagues and friends.

The Stress Factors in Dentistry

Running behind schedule and constant time pressures are the top stress factors for dentists, according to a survey done by Molar Enterprises, reports Gary Stough, DDS, in the January *GDA Action*, journal of the Georgia Dental Association.

A comprehensive, 50-question survey was mailed to 14,000 dentists nationwide, the article reports. Questions pertained to areas of stress within a dental practice in an attempt to gain insight into how stress affects the professional and personal lives of dentists.

Respondents were asked to rate each stressor on a scale of 1 to 4, with one being little or no stress and four being the most stress. The areas ranked as being most stressful were running behind schedule and constant time pressures.

Other stressful areas were:

- · high expectations of self
- · dissatisfied, ungrateful patients
- · anxious patients
- · need for things to be perfect
- · desire not to fail
- · desire to avoid conflict
- · expectations of perfection
- · staff relationships.


Stough notes that of the top 15 stressors, about half were directly patient or staff related.

Of the survey respondents, 26 percent said they had a divorce (below the national average) since starting to practice dentistry. Of that percent, 47 percent stated that financial and/or professionally related stress was a major factor in their divorce.

The survey also found that of respondents who have been in practice for 20 years or more, 41 percent rated financial concerns a 3 or 4- very stressful. Stough also reports that 38 percent of respondents felt they are experiencing or sometime in their career have experienced burnout.

Stough reports that complete survey results of *Dentistry: The Stress Factor (Understanding and Coping with Distress)*_ will be published sometime this year.

LSUSD Library is open to all La. Dentists

The LSUSD library offers its services and resources to all alumni of the dental school and to all dentists practicing in Louisiana. With a collection of 9000 books and 1100 journal titles on dentistry and related subjects, the library provides a valuable resource to dental professionals.

In addition to the 180 current journals and 200 books added last year, electronic databases and web sites enable the dental library staff to find the latest information. The staff, which includes two professional librarians, is dedicated to assisting Louisiana dentists.

Patrons don't even have to come into the library; they can telephone, fax, or e-mail requests for information, photocopies of articles, or literature searches. Of course, those in the New Orleans area who wish to visit the library may check out books, browse the collection of current journal issues, or photocopy articles at 10¢ per page.

The LSUSD library web site at www.lsusd.lsuhsc.edu provides a link to the online catalog (Innopac) for the identification of books and journals in the library. In addition, the dental library web site has library hours, a list of recent library acquisitions, the Llbrary Explorer – the quarterly newsletter – information about services for dentists, and links to other sites.

A link on the library home page to PubMed, the gateway to MEDLINE at the National Library of Medicine, makes it easy for one to connect and to search for journal articles.

Clicking on "Dental Practitioners" leads to information about Loansome Doc, the electronic system for ordering copies of articles identified in PubMed.

For those not interested in searching MED-LINE themselves, the librarians will be glad to run literature searches and can easily e-mail the list of citations with abstracts. The next NODA event in March was the President's Banquet honoring the 2002 NODA Board of Governors on March 9. Thanks to Dr. Terry Fugetta for a great job as my master of ceremonies; Mona and the rest of our Central Office staff for helping me coordinate the evening, and my wife Gwen – for getting the flowers. As I announced in last month's NODA News, congratulations to Dr. Milford Kathmann for receiving this year's NODA Honor Dentist Award.

Also on March's agenda was the annual LDA house of Delegates meeting which was held in Baton Rouge on Saturday, March 16. On behalf of the NODA membership, I would like to thank our delegates to the LDA HOD for giving of their time and making this a successful meeting! Dr. Glenn Dubroc deserves a special thank you for all of his work. He helped enough delegates understand that the proposed \$75 increase in LDA dues was unwarranted with the information provided to us, the delegates.

NODA proposed a \$20 increase based on what we could understand was needed to fund the rising cost of doing LDA business. This was defeated, along with an amended \$50 increase. What finally passed was a compromised \$35 increase in LDA dues. We hopefully got LDA leadership's attention in that if they want an increase in our dues, they should be able to show what the committees need so that proper funding is provided.

The three-year public relations campaign was not renewed therefore effectively giving each member a \$150 DECREASE in dues. Thanks to Greater Baton Rouge Dental Association for submitting the amendment and doing their homework . . . it passed!

At this meeting, Drs. Edmund Ganucheau, Jr. and Dr. John Kent received the LDA Distinguished Service Award. An honor much deserved by both for their outstanding contributions to our profession! Also, Dr. Mark Chaney was installed as LDA President-Elect, Dr. Eric Hovland was elected as a Delegate to the ADA, and Dr. Robert Barsley was elected as an Alternate Delegate to the ADA. Congratulations to all!

We have accomplished and are able to accomplish so much in organized dentistry and in our NODA Community . . . the bottom line is that we need to keep NODA strong. We will continue to partner with the LDA and ADA to improve our membership. I am committed to that as a NODA Member, as your President. Just think if there was no ADA, no LAD, no NODA?? I hope you agree with me that that is incomprehensible and that we are getting the proverbial "bang for the buck," that our professional life would be considerably worse and more complex without organized dentistry.
