# Facts About Older Adults

- 32 million Americans are age 65 or older. This accounts for approximately 13% of the population.
- 3.3 million Americans are 85 or older, and this number is expected to grow by 100%, to over 6 million, by the year 2010.
- People over age 50 account for 26% of the population and will reach about 30% by the year 2000.
- 85% of Americans over 50 do not identify with people their own ages, but with individuals 5 to 10 years younger than themselves.
- After age 35, it is estimated that three out of four adults have some form of periodontal disease.

- Periodontal disease is a leading cause of tooth loss in adults.
- About 95% of all oral cancers occur in persons age 40 and older. When mouth cancers are detected early, survival rates increase dramatically.
- Oral cancer accounts for 4% of all cancers.
- The average life expectancy in the United States exceeds age 74.
- Approximately 42% of Americans over age 65 are totally edentulous (toothless).
- Almost 40% of all prescription drugs are used by people over the age of 60.

Dr. James W. Briggs and Dr. Charles T. McCabe are once again co-chairmen of NODA's areawide observance of National Senior Smile Week May 15-21.

"Put Your Best Smile Forward" is the theme of the nationwide event.

Drs. Briggs and McCabe plan appearances at nursing homes, senior centers and other spots to acquaint older citizens with methods for preserving their natural teeth and maintaining overall dental health.

"We urge all interested dentists to volunteer to give us a hand at any of the appearances that are arranged," said Dr. McCabe. "If you wish to help out, just call my office at 392-4734."

The over-55 population is the fastest growing age group in the United States and is also the most susceptible to dental problems, including periodontal disease, major cause of tooth loss in adults; tooth root decay, dry mouth, and diseases such as oral cancer, according to the American Dental Association.

National Senior Smile Week was initiated seven years ago by the ADA to call attention to these problems and urge the importance of maintaining good oral health care throughout life.

# Dentist census underway

In late February the American Dental Association's Survey Center began the second year's effort in a multi-year census of all dentists in the United States and its territories.

The census began in 1993 and will be completed in 1995. In 1994, almost 60,000 dentists will be contacted.

The "Distribution of Dentists in the United States," which presents state and regional-level data on professionally active dentists and private practitioners, will be updated using data from the census. The information will also be used to update the Association's "State and County Demographic Reports," often used by dentists seeking a practice location.

This is the largest census survey ever conducted by the Association since the first Distribution of Dentists was published in 1946.

The questionnaire requests only basic information from the dentist – current occupation, practice area or specialty, date of birth, date of retirement (if applicable), gender, race and eth-

nicity, and practice ownership and licensure status. Dentists are also asked to update their mailing address, if necessary.

Karen Schaid Wagner, the assistant director of the Survey Center, urges all dentists to complete and return the postage-paid census form promptly so that the Association can immediately update its records and avoid follow-up mailings.

#### IT'S HIS DENTIST


Many people familiar with artist Grant Wood's painting "American Gothic" assume his models for the couple were an Iowa farmer and his daughter.
