# Anxiety in the dental office: a study reveals fear still present

CHICAGO – An overwhelming majority of Americans continue to mention their fear of treatment in the dental office, creating extra stress in the dental office, according to a new poll conducted by the Chicago Dental Society of its members.

About 95 percent of dentists say their patients mention fear of treatment or dental procedures.

When treating patients who are fearful, almost two out of three dentists (64 percent) indicate that patient fear makes treatment somewhat stressful. About 25 percent of

respondents indicate that patient fear makes treatment very stressful.

However, about 96 percent of dentists say they undertake specific procedures or services to make patients less fearful of pain during dental treatment.

Other results of the perception of pain poll include the following:

• About 41 percent of dentists indicate that no more than 10 percent of their patients mentioned pain or fear of dental treatment. More than half (59 percent) indicated that no more than 20 percent indicate fear and 79 percent indicate that half of their patients seem to be fearful.

- When patients mention they are fearful, almost 9 of 10 dentists (89 percent) indicate they are somewhat (37 percent) or very (51 percent) convinced of the patient's claims about fear.
- About 96 percent of dentists report they have a signal system for the patient to use when treatment has become too intense for them.
- In comparing fear between males and females, 65 percent of dentists report that men (Continued on page 4)

# Pierre Fauchard Academy solicits grant requests

The Foundation of the Pierre Fauchard Academy has accumulated a substantial capital fund through the annual contributions by its fellows and from a generous legacy from the late Dr. Fernando Brenes-Espinach of Costa Rica.

These funds have been invested and the interest, estimated to be approximately \$300,000 annually, will be available to fund student scholarships and grants requests from various dental programs and projects.

Beginning in the 1996-1997 academic year, the sum of \$100,000 has been designated for student scholarships. Each of the 54 dental schools in the United States will annually be awarded \$1,200 for a deserving student. Twenty eight awards will be available for students attending the non-U.S. dental schools.

In addition, the Foundation has designated \$200,000 annually to be awarded to the

Grants/Projects Program that will benefit the dental profession and the public it serves. Approximately \$65,000 was awarded to various dental programs in March of 1996. Another \$105,000 will probably be awarded in September of 1996.

Organizations, institutions and individuals who desire funding for their programs are encouraged to contact the Executive Director of the Foundation to obtain the Foundation's Informational Circular, which pertains to the types of grants the Foundation will fund, and information regarding the application procedure relative to the Foundation's Grants/Projects Program.


## DEFEATED BUT UNDAUNTED

# Dr. Dummett: Dentistry, teaching run in the family

he name of Clifton O. Dummett, Jr. may not be a household word to the average New Orleanian, but among pediatric dentists and other practitioners who attend national meetings and conferences, it is becoming more familiar.

In recent months, for example, the 52-yearold NODA member and LSU Dental School professor has presented scientific programs for the American Academy of Pediatric Dentistry in Tampa, the California Dental Association in Anaheim, and the Toronto Academy of Dentistry in Toronto, Ontario. He has become visible on the programs of the Chicago Dental Conference, Hinman Dental Meeting in Atlanta, and, of course, the New Orleans Dental Conference, among others.

A career in dentistry and in teaching came naturally to Dr. Dummett. His father served as dean of the School of Dentistry at Meharry College of Dentistry in Nashville, and subsequently, chief of dental services at the VA Hospital in Tuskegee, Alabama, before joining the dental faculty of the University of Southern California in Los Angeles. Now retired, the senior Dr. Dummett is professor emeritus at USC and "is still very active in dentistry," says his son.

A native of Chicago with early childhood years in Tuskegee, Alabama, Dr. Clifton O. Dummett, Jr. is a graduate of Lenox Preparatory School in Lennox, Massachusetts. He earned his bachelor's degree from Earlham College in Richmond, Indiana, and went on to earn his D.D.S. and M.S.D. degrees at Indiana University and his M.Ed. degree at the University of New Orleans.

After graduating from Indiana University, he became coordinator of dental research at the Children's Medical Center in Dayton, Ohio, and director of pediatric dentistry at the Charles R. Drew Neighborhood Health Center in Dayton.

In 1974, LSUSD acting dean Dr. Allen Copping began Dr. Dummett's 22 years at the dental school, where he now serves as professor and coordinator of postgraduate pediatric dentistry and chief of the pediatric dentistry section at Charity Hospital.

Dr. Dummett says his life at LSUSD has been stimulating and professionally gratifying. "Especially satisfying," he continues, "have been my relations with the New Orleans Dental Association as well as participating in the New Orleans, Hinman, and Chicago Dental Conferences. I cherish my LSUSD associations with my department head, Dr. Bob Musselman, Dr. Copping, the other wonderful deans and faculty I have had the pleasure to work with."

As director of LSU's advanced education program in pediatric dentistry, Dr. Dummett says he especially enjoys working with new dentists pursuing pediatric dentistry as a specialty career.

Many activities with the American Academy of Pediatric Dentistry, including chairmanship of the AAPD education and the public professional relations committees have led to a three-year term on the Board of Trustees.

Dr. Dummett is a diplomate of the American Board of Pediatric Dentistry and is licensed to practice in Illinois, Indiana, Louisiana, and Ohio. He has lectured at dental meetings internationally in Jamaica, Brazil, Costa Rica, Mexico, and Canada.

Judging from his conversation, some of his happiest days have been spent in New Orleans where he resides with his wife of 27 years, Dottie, of Elmira, New York. The Dummetts have a passion for sailing and in their spare time can be found plying the waters of Lake Pontchartrain on their 30-foot sailing sloop.

and women are equally likely to fear dental treatment. About 30 percent report that males are more likely to fear dental treatment; less than five percent say that females are more likely to fear treatment.

- Compared to 25 year ago, about 57° percent of dentists report that patients today perceive dentistry as somewhat pain-free, while another 35 percent indicate patients today perceive dentistry to be very pain-free.
- About 35 percent of dentists indicate that patients 35 to 49 years of age are the most fearful. About 31 percent believe that patients 10 years and younger are the most fearful.
- About 27 percent of dentists say they believe children today are must less fearful; 30 percent say children are somewhat less fearful; and 31 percent say children are no more or less fearful of dental care, compared to a generation ago. Eight percent of dentists say the question does not apply to their practices.
- Roughly 88 percent of dentists say that a parent or older relative is most responsible for portraying to children the concept of dentistry as painful. About 74 percent believe a sibling or a friend is most responsible. This compares to 66 percent of dentists who believe that children perceive dentistry as painful because of a painful experience in the dental office.
- Dentists strongly believe that a variety of media sources exploit the concept of dentistry as painful. Movies were rated by 86 percent of dentists as the media source most likely to contribute to the concept of pain.

# X-RAY SAFETY an Update

radiation inspector with the State of Louisiana occasionally encounters confusion in the dental office concerning the state's x-ray paperwork requirements. In Louisiana, dental x-ray machines fall under the jurisdiction of the Department of Environmental Quality – Radiation Protection Division (LDEQ-RPD).

It is important to realize that all regulations pertaining to sources of radiation are listed in a section of Louisiana's Administrative Code called the Environmental Regulatory Code, Title 33, Part XV: Radiation Protection (LAC 33:XV). The following is a concise guide to the LDEQ-RPD paperwork requirements associated with the ownership and use of dental x-ray equipment.

#### I. REGISTRATION OF X-RAY UNITS

- Registration: As most dental professionals are already aware, every dental x-ray console must be individually registered with LDEQ-RPD using form DRC-6, "Application for Registration of a Radiation Source." (LAC 33:XV.204.1)
- 2. Fees: For each unit, an initial application fee (\$79), and annual renewal fees, \$73 per year must be paid to LDEQ-RPD on a timely basis. In only one situation may an x-ray machine be exempt from the annual fee: the unit is disassembled and contains defective or broken components such that if reassembled in its current condition, it could not produce a beam of radiation. Viable, disassembled x-ray units in storage are *not* exempt. (LAC 33:XV.2505)
- 3. Change of information: The registrant must notify LDEQ-RPD in writing before making any change that would render the information in the application for registration and/or registration certificate no longer accurate. Examples include change of ownership, change of address, disposal, disassembly or storage of a unit. It is not necessary to notify LDEQ-RPD for changes to components other than the x-ray console (such as x-ray tube replacement). (LAC 33:XV.209).

#### II. POSTING REQUIREMENTS

1. Certificate of Registration: Every x-ray unit must have its individual certificate of registration posted on or near the unit. One acceptable practice would be to place the folded certificate in a small plastic bag and tape it to the bottom of the control console. Other methods of posting the form on or near the machine may be

used. (LAC 33:XV.1011.A.2 and form DRC-7)

- 2. Louisiana Radiation Regulations: Each registrant must possess a current copy of the relevant chapters of LAC 33:XV. The Louisiana Dental Association (LDA) publishes this in an LDEQ-sanctioned format. Additionally, the location of the regulations, or the regulations themselves, must be prominently posted in the dental office. Form DRC-3 (see #3 below) may be used to note their location. (LAC 33:XV.1011.A.1)
- 3. "Notice to Employees": Each registrant must post form DRC-3, "Notice to Employees: Standards for Protection Against Radiation". The form may be posted in a location out of view of patients, but must be readily viewable by all employees. A line on form DRC-3 is reserved for the registrant to note the location of the LAC 33:XV book or booklet; e.g., on a shelf by the reception area, or a particular file drawer. (LAC 33:XV.1011.C)
- 4. **Developer Chart:** Near each developing tank or automatic processor must be posted a chart showing film developing time at given developing fluid temperatures. This chart may be obtained from the processor manufacturer, or the tables shown in LAC 33:XV.603 may be used. (LAC 33:XV.603.B.1.b and 603.B.2.b)
- 5. **Technique Chart:** A technique chart must be posted by each x-ray control console which includes (at a minimum) the technique factors (e.g., kVp, mA, time) to be used for children versus adults. This chart may be obtained from the x-ray unit manufacturer, or developed from the registrant's experience with a particular machine. (LAC 33:XV.603.A.3)
- 6. Warning Label: Attached to each x-ray control panel must be a warning label which legibly states the following: "Warning: this x-ray unit may be dangerous to patient and operator unless safe exposure factors and operating instructions are observed." These labels are not provided by LDEQ-RPD, so contact the x-ray unit manufacturer or supplier to obtain them. (LAC 33:XV.604.1)


