

# 52nd ANNUAL NEW ORLEANS DENTAL CONFERENCE FEATURES WIDE-RANGING EDUCATIONAL PROGRAM

PRE-CONFERENCE COURSE

"Achieving Aesthetic Excellence" is the title of the All-Day Pre-Conference Course of the New Orleans Dental Conference Wednesday, September 19 in the Morial Convention Center.

Dr. Robert L. Nixon of Beverly Hills, California will conduct the course. He is a Fellow of the American Academy of Cosmetic Dentistry and the American Society of Dental Aesthetics and is co-director of the Center for Aesthetic Excellence in Chicago, Illinois. He maintains a practice emphasizing aesthetic restorative dentistry in Beverly Hills, California.

The program, known as the Dr. Louis G. Grush Distinguished Lecture Series, provides a comprehensive blend of traditional principles with recent advancements to equip the progressive dentist for aesthetic dentistry in the new millennium.

star-studded program that runs the gamut from aesthetics to murder (that's right, murder) awaits attendees of the 52nd annual New Orleans Dental Conference September 19-22, 2001 at the Ernest N. Morial Convention Center.

Last year's conference drew participants from 41 states and Canada. It is hoped this year's session will top that figure.

The various clinics and lectures have been moved to facilities at the northern end of the convention center, closer to Canal St., saving some walking on the part of the attendees. A total of 46 sessions will be held, covering a wide range of clinical, management and motivational topics, several of them twice to serve the maximum numbers of participants.

Aesthetics will be thoroughly covered in the all-day pre-conference course by the noted restorative dentist Dr. Robert Nixon of Beverly Hills, California. (See description at left.) "Murder" as it involves dentistry will be covered in sessions by forensic dentists Dr. Michael Baden and Dr. Philip Levine.

Dr. James B. Maas of Cornell University will be the keynote speaker at the Opening Session Thursday at 8 a.m. A noted authority on sleep and performance, he has made a number of movies on the subject and has been featured on the Oprah Winfrey TV show. (See article at right.)

Following the Opening Session, the crowd will "second line" to the Exhibit Hall for free pastries and coffee and a drawing for a \$500



"Do You Want to Know the Secret of Life?" is the title of the keynote address at the Opening Session of the New Orleans Dental Conference Thursday, September 20 at 8 a.m. in the Morial Convention Center.

There will be a NODA general membership meeting on Wednesday, September 5, 2001 in Auditorium A, LSUSD. As usual, the business meeting will begin at 7 p.m. with the scientific program immediately following (presenter to be announced). A motion was passed at the May general membership meeting to table the proposed bylaw amendments with the ad hoc committee addressing suggestions made at the May meeting and reporting its results at this September meeting. These changes will be sent with the next NODA News. I encourage each of you to attend the meeting for discussion and voting on the bylaws changes. These changes are being made to integrate the timing of our elections with that of the LDA.

n another important note, the Louisiana State Legislature recently passed House Bill 1583 which allows the State Board of Dentistry to seize dental records (including original x-rays) without notice under certain circumstances. The resolution to allow the LDA to lobby for this passed by one vote (with three votes abstaining) at the LDA House of Delegates meeting in March 2001.

All 23 New Orleans delegates voted against this at the House of Delegates. The vote taken at the House of Delegates was disorganized and confusing. Objections were raised at the procedure of voting at the end of the session before adjournment. The presence of several State Board members along with the fact that several delegates had adult sons and daughters taking the State Board Exam in the next week inhibited discussion on this issue.

When this issue came up two years ago, others and I stood up against it. Because of my stand against it, I was selected to serve on a task force along with several others to meet

with the State Board and work to explore common ground of agreement. The resolution presented this year, though much more reasonable than what was proposed two years ago, was still basically a loss of protection to the average good dentist out there plugging away.

The system in place has allowed the board opportunity to stop the wayward dentists when necessary. They have done an excellent job. With this new law, it seems the potential rights of many could be violated in pursuit of a very few. Good records in your possession are your protection against charges that may be filed.

I received many calls asking for my support against this at the legislative level and I presented the case against it to as many legislators as possible in order to defeat its passage. I wrestled with the fact that on paper, this appeared as an LDA endorsement, but in fact, for the reasons listed above, I don't believe it was and I followed my conscience. Therefore, I fought against it. Nonetheless, the bill passed the Senate and has been signed by the Governor. It is now officially in the State Dental Practice Act.

Some members of the State Board have assured me that this is a good bill that will not be abused. I am trusting that will be the case.

We have an exciting year ahead of us. Thanks so much for your support and help through the year.





## Baldridge Chair to Dr. Fidel

Dr. Eric Hovland, dean of LSUHSC's School of Dentistry, has announced that Paul L. Fidel, Jr., Ph.D., professor in the department of microbiology, immunology, parasitology at the LSU Health Sciences Center will hold the Dr. Carl Baldridge Chair in Oral and Craniofacial Biology and has been appointed director of the Center of Excellence in Oral and Craniofacial Biology. The appointment was effective May 1.

A graduate of the University of Oklahoma, Dr. Fidel has authored 67 publications and served as investigator for 17 research grants totaling more than \$8 million, 10 of which were from the National Institutes of Health. Dr. Fidel serves on various NIH research review committees.

The Center of Excellence will foster collaboration between basic science and clinical science departments. It will also create a research environment for students, postdoctoral fellows, and faculty researchers in dental and craniofacial biology.

Generic drugs cost less because they don't require the same costly research, development and sales expenses associated with brands. It's estimated that nearly one-fourth of the cost of a brand-name drug is spent on marketing and advertising.
